Solar Water Heating Systems

New solar water heater installations which replace or supplement the existing domestic hot water service are eligible for the following rebate payments from Waverly Utilities.

- \$30 per square foot of collector area
Maximum incentive capped at \$3,500.

To Apply for your Incentive:

- 1) Get a bid for your project first.
- 2) Complete the Solar Hot Water Heater Rebate Application, include a copy of your contractor's bid, and send to:

- 3) Customer will receive notice whether your project is approved within two weeks of Waverly Utilities (WU) receiving your application. Waverly Utilities recommends you do not purchase, order, or install any equipment until you have received written notice that your project is approved.
- 4) Customer will have three months (90 days) from the date of approval to complete your project. When your project is completed, return a duplicate copy of your approval letter, Solar Hot Water Heater Rebate Claim form, a copy of your paid sales receipt, and Bremer County building permit to receive your rebate.

Program Terms and Conditions:

- 1) Effective date of program is January 1 through December 31, 2023, **or until funding is depleted.**
- 2) Rebates are based on eligibility criteria. Waverly Utilities reserves the right to modify, amend, or terminate the solar hot water heater rebate in whole or in part at anytime and for any reason without prior notice.

- 3) Customer/Purchaser agrees that the product purchased must be for primary use in a residence with an active meter receiving Waverly Utilities electric service.
- 4) Customer account(s) must be current on previous 12 months of Waverly Utilities billing to be eligible.
- 5) Qualifying systems must not be installed prior to written authorization from Waverly Utilities.
- 6) Product must be NEW/undamaged active solar equipment, either flat-plate or evacuated-tube collectors. Products that are resale, rebuilt, rented, leased, exchanged, or won as a prize are **not** eligible for rebates.
- 7) Solar thermal equipment must be certified by the Solar Rating and Certification Corporation and backed by a manufacturer's warranty to qualify for a rebate from Waverly Utilities.
- 8) Rebate payments may not exceed the total installed cost.
- 9) Rebates are limited to one rebate per customer/purchaser's premise.
- 10) Customer/Purchaser is solely responsible for installation of all rebated products to the manufacturer's specifications. This includes obtaining necessary building/mechanical permits and completing the inspection process as required by local jurisdiction. All electrically-operated components must meet applicable safety requirements of the National Electric Code.
- 11) Waverly Utilities makes no representations or warranties expressed or implied regarding the design, sizing, installation, construction, reliability, efficiency, performance, cost savings, and operation. Any decision regarding the selection, design, installation, use, and operation of systems and equipment shall be at the sole discretion and are the sole responsibility of the customer. Waverly Utilities is not liable or responsible for any act or omission of any contractor whatsoever.
- 12) Customer/Purchaser agrees that Waverly Utilities reserves the right to inspect the installation premises or request additional documentation prior to rebate payment. Rebate may be denied by Waverly Utilities if this condition is not met by customer/purchaser.
- 13) A copy of applicable Bremer County building permits is required as part of the final approval process.

Certification and Agreement:

I understand that this offer provides incentives for qualifying solar hot water systems currently receiving electricity from Waverly Utilities. The system described in this application meets the appropriate certifications from the Solar Rating and Certification Corporation and has been installed in accordance with the National Electric Code and all applicable local ordinances.

I agree that Waverly Utilities reserves the right to verify sales receipts and/or installations before issuing incentives on qualifying solar hot water systems purchased and installed before December 31, 2023.

With my signature, I certify all statements made in this application are correct to the best of my knowledge and acknowledge the terms and conditions of the Solar Hot Water Rebate Program as set forth on this application.
